## Representative Matters

- Cleanup. Regularly represents clients on environmental liability and remediation issues, including cost allocation, cleanup implementation, access for cleanup, resolution of liability through consent decrees and agreed orders with state and federal regulators, and related private agreements among responsible parties. Many of Matt's projects involve shorelines, shorelands and sediments. Major projects include representation of a responsible party in cost allocation and cleanup issues at the Portland Harbor Superfund site and complete settlement of all claims related to a century of historic contamination at the Thea Foss Waterway Superfund site in Tacoma, Washington.
- I Natural Resource Damages. Represents a responsible party in cost allocation and settlement negotiations involving dozens of parties and federal, state and tribal trustees over natural resource damages claims at the Thea Foss Waterway in Tacoma. Represented the state-designated trustee in its restoration-based resolution of NRD claims arising from a gasoline spill and explosion along a Whatcom creek in Western Washington. Represented the responsible party in achieving the first state-only NRD settlement in Washington.
- Due Diligence. Matt represents buyers, sellers and lenders in transactions involving contaminated property or the risk of contamination. Recent transactions include representing the buyer of several large commercial properties in Seattle.
- I Water Rights. Represents the only municipal major claimant in the general stream adjudication for the Yakima River, the largest and longest-running water rights adjudication in Washington, helping to achieve comprehensive settlement of all the municipality's claims. Matt also regularly represents clients before Ecology and local water conservancy boards on water rights permitting, acquisition, transfer and management matters, including permitting for aquifer storage and recovery. He represents buyers, sellers and lenders in transactions involving water rights, including due diligence, documentation and trust transfers. Matt also assists clients with water right portfolio reviews, and developing and implementing related permitting strategies for aligning existing rights with water system needs.
- Hydropower. Represents a municipal utility in implementation of Federal Power Act licenses. Current work includes property acquisition and water rights portfolio management.
- Project Permitting. Represented a Washington port district in all aspects of permitting and environmental review for construction of a rail-barge facility in Puget Sound.
